National Environmental Policy Act 1969


Purpose:

To declare a national policy which will encourage productive and enjoyable harmony between man and his environment; to promote efforts which will prevent or eliminate damage to the environment and biosphere and stimulate the health and welfare of man; to enrich the understanding of the ecological systems and natural resources important to the nation; and to establish a Council on Environmental Quality.

Council of Environmental Quality (CEQ)



Develop national policies to foster and promote the improvement of environmental quality to meet the conservation, social, economic, health, and other requirements and goals of the Nation.



CEQ Regulations

- Information available to the public
- High quality, accurate scientific analysis
- Concentrate on issues that are truly significant
- NOT to generate paperwork
- Protect, restore, and enhance the environment





A Compelling Need
