Introductions and Meeting Minutes

All those present introduced themselves. The group discussed meeting objectives:

- Develop a path forward/strategy for how to structure development of the Bottom Canyon alternative. Match up topics with meeting schedule over the winter and various milestones
- Discuss how the committee will communicate/share information (project website)

Alternative Development

Data: no further stand exams were able to be done by the TEAMS enterprise team this fall due to the government shutdown. The group discussed forging ahead using the data that is available. 90% of the stand exams are completed for the initial FS proposal, and 75% of the data is entered. That accounts for 2300 acres of stand exams.

Question about root disease and extent through area? Answer: root disease is through the entire area.

If the group is able to identify screens or filters (for example, merchantable timber), then Chad Hudson offered that his staff could develop maps to show the data visually. The group discussed using the Northwest Management/Bob's map as the base upon which the screens would be overlaid.

The group discussed various approaches/next steps for quite a while, then arrived at the following schedule:

GRAIP combines a detailed road inventory with a powerful GIS analysis tool set to predict road sediment production and delivery, mass wasting risk from gullies and landslides, and road hydrologic connectivity.) Kajsja Stromberg at the Idaho Dept of Environmental Quality will coordinate with Aaron (?), Forest Service hydrologist, to incorporate Total Maximum Discharge Load information in this presentation.
