1. Welcome and opening business – Dave Schultz

- Dave Schultz opened the meeting and all attendees introduced themselves.
- The July meeting record was approved.

Forest Service Announcements

- Flint Foothills decision signed in July, and the first contract will be advertised 9/16.
- Aspen CE decision memo signed in July.
- Boulder Lowlands contract awarded to RY in the last week of August. The timeline for implementation isn't settled yet.
- The second sale on the East Deerlodge Valley Landscape project (Gerard Perkins) was awarded to Sun Mountain.
- There have been no Freedom of Information Act requests or notices of intent for any of the projects.

State of Montana Announcements

- Governor Bullock is starting his term as chair of the Western Governor's Association.

- Funding was awarded through Forests in Focus to the Beaverhead-Deerlodge National Forest (BDNF) for the Greenhorn and Pintler Face projects. Over the last two years, the BDNF received a total of \$207,000 out of the \$1,823,000 allocated (11% of the total).

This includes \$17,000 of funding in the first year to support BDWG collaboration on the Boulder-Lowlands project, and \$15,000 in the current year to support collaborative engagement in Pintler Face and Greenhorn.

- The State's Forests in Focus funding for restoration on state/private/county/Tribal lands is offering \$1.5 million through a third round of applications.

6. **Western Governor's Association Panel**

Tony Colter was invited to present at the WGA workshop on a panel about collaboration. He asked the BDWG to provide thoughts about the keys to successful collaboration.

- Field trips
- Lunch, beer, cookies

7. **Pintler Face**

Pam Fletcher, interdisciplinary (ID) team leader, provided an overview of the Pintler Face project.

- The scoping period is open through Tuesday, September 27th.
- The BDNF has received a lot of comments regarding the vagueness of the scoping, lack of acreages, etc.
- The FS has now posted three detailed maps online.
- The FS is in the early stage of data collection.
- The area is likely to shrink once the data is gathered.

- This fall, the BDNF will review scoping comments, field data, etc.
- In early 2017 (January ?), will work to develop the environmental analysis
- The BDNF is interested in engaging with the BDWG on the project.
- The BDNF's intent is to make the project development process iterative, and that's why they intentionally scoped it broadly.
- Assessing 5500 acres of commercial harvest of lodgepole pine; 300 acres precommercial thin of Douglas fir, 4800 acres conifer removal (noncommercial removal using saws and fire for conifer encroachment).
- 350 miles of roads and trails are officially in the project area, but many of the roads on the project are already "haired in" – functionally closed.
- The total project area is 150,000 acres (entire Pintler management area)
- 18,000 treatment acres.
- Aquatics discussion will happen when data from road condition field surveys comes in.
- FS looking at units right now
- Interested partners: Rocky Mountain Elk Foundation, CFC (?)

Discussion:

- Proposed action addresses a range of conservation and management needs
- Process seems collaboratively inclined, and people on the BDWG appreciate that
- The FS and the timber industry aren't in complete agreement about timber valuation.
- Groups submitting comments: Greater Yellowstone Coalition, Sun Mountain Lumber, State of Montana

8. Collaborative Integrated Forest Assessment Project

- During the NFF's Collaborative Restoration Workshop last April in Denver, Alex Dunn learned about a Region 6 process involving the Pacific NW Research Station, (PNWRC) Oregon State University, The Nature Conservancy and other partners. They took existing data and ran it through analysis to identify priority areas for restoration over a large landscape in the Blue Mountains. The technology helped advance the discussion.
- The high level analysis supported smaller projects.
- The analysis can help tell the story of why here, why now; understanding cumulative effects; discussing tradeoffs.

Action:

- Schedule this for a future agenda to learn about how different groups have accomplished forest-wide assessment using data tools (NEWFC, Okanogan-Wenatchee NF, PNWRC)

9. Boulder River Landscape

- Boulder Lowlands: As stated above, the timber was sold in August. Winter logging restrictions will affect the timing of implementation. Still aiming for an implementation field trip this fall. Mo Bookwalter asked if the BDWG has considered issuing a press release to acknowledge the sale of Boulder Lowlands. The group discussed this and asked the Steering Committee to discuss next steps.
- Red Rock: Field trip is planned for Thursday, 9/21. More information on logistics will be available on Tuesday. Development of the EA will be a 2 year process. Between now and February is the “pre-NEPA” collaboration opportunity. The BDNF will have a kick off with the ID Team in early October, and transfer data.
- Landscape Strategy: The Boulder River Committee met for two hours before the BDWG meeting and made progress on the landscape strategy.

Actions:

- The Steering Committee will discuss publicity around the Boulder Lowlands at its next meeting.
- Schedule a teleconference meeting of the Boulder River Committee to continue work on the landscape strategy.

10. Selway Meadows Landscape

- The irrigation work is happening. Flows are low.
- Committee members include Nick Jose, Brian Ohs, Tom Rice, Darcie Warden, Mark Thompson, Nick Gevock, and Nathan Korb, plus some representatives of Montana Fish, Wildlife & Parks.
- Haley Wiggins is working on developing a set of maps and background information similar to the information she put together for the Boulder River landscape, to help support the discussion around the landscape strategy.

Actions:

- The NFF will send around a doodle poll to set up a Selway Meadows committee meeting in Dillon sometime in October.
- Request to have Haley also prepare maps for the Clark Fork-Flints landscape.

11. Carcass Removal (quick update)

- Montana Wildlife Federation applied for a grant to remove wild game carcasses and compost them as a way to reduce human-bear conflicts.
- A compost facility is being built in Wisdom and Madison County. There’s already one in Clearwater Junction that has been very successful and has reduced grizzly bear conflicts with humans by 93%.

Action:

- Add carcass removal and composting to the October meeting agenda.

- Alex Dunn shared information about where to find the most up-to-date project information on the BDNF website. The SOPA, or Schedule of Proposed Actions, lists the status and links to further information on BDNF projects.
